On behalf of the Board of Directors of the Morgan Hill Homeowners Association, we respectfully request the City of Temecula, the Temecula Valley Unified School District, the Riverside County Sheriff's Office and the Board of Supervisors of the County of Riverside address the issues of e-bike and electric scooter safety. We understand that the popularity of these items has far exceeded the ability of our Legislature and local government/law enforcement to create and pass new laws, defining what is legal. It has become apparent that an enormous number of young people (students) are the ones who urgently need instruction. We are suggesting a combined effort including schools, law enforcement, County and community services require e-bike/electric scooter safety instruction.
